No.UAU. 73/2016/Pt.VII/97 - In exercise of the powers provided under Section 74 of the Meghalaya Town and Country Planning Act, 1973 as amended (Assam Town Planning Act, 1959) and the National Building Code, 2016, the Government of Meghalaya is pleased to amend the Meghalaya Building Bye-Law, 2021 and notify as follows, namely,-

- 1. Short title and commencement (1) These Byelaws maybe called the Meghalaya Building (Amendment) Byelaws, 2025.
 - (2) It shall come into force from the date of notification in the official Gazette.

2. Amendment of Section D-2:

In the Building Byelaw, D2, Table D-2, the existing provisions for Industrial Building at SI no. 5 and 6 shall be substituted as follows, namely:-
