No.UAU.53/2020/33 - In view of the limited participation during the Kick Start Fund stage of the My City Campaign and the announcement of the Hon'ble Chief Minister to support beautification efforts, localities shall be classified based on parameters such as area and population for extending beautification grants. Localities identified as eligible through this classification process may be considered for support. Accordingly, the following provisions are hereby added to the Guidelines of the My City Campaign:

- (i) The competent authority, i.e., the Urban Affairs Department (UAD), shall determine the category of each locality for beautification grant allocation.
- (ii) The Director, Urban Affairs shall be authorized to release the sanctioned funds under the beautification grant of the My City Campaign.
- (iii) To initiate the beautification efforts, UAD may select a few localities to pilot the initiative by developing Instagrammable streets as model urban spaces, with the objective of enhancing the city's visual appeal and promoting tourism.

This Notification shall be deemed to form part of the My City Campaign Guidelines and shall take effect immediately.
