

No. UAU.110/2020/Pt.I/74 - In exercise of Section 39 of Meghalaya Town and Country Planning Act 1973, the Governor of Meghalaya hereby allows Change of Landuse within the notified Master Plan Areas of the State. For this purpose, the State Government hereby adopts the following procedure for approval of the Change in Landuse:

- 1) Application to be accepted through online portal: Citizens can login to Unified Investment Portal (UIP) at https://invest.meghalaya.gov.in for application of the same.
- 2) Steps for scrutinization as detailed below:



- 3) Fees: A nominal fee to be charged as per rates notified by the State Government from time to time which will be paid at the time of application.
- 4) Timeline: CLU processing shall ordinarily be completed within 30 days of complete application receipt.
